BYLAW #645

BUSINESS LICENSE AMENDMENT TO BYLAW #624

BEING a Bylaw of the City of Iqaluit, a Municipal Corporation in Nunavut to amend “Schedule B” of Bylaw #624, which states the business license fee schedule for businesses operating in Iqaluit.

WHEREAS, pursuant to the *Cities, Towns and Villages Act*, R.S.N.W.T., C.c-8, Section 65, a council, by bylaw, may amend, repeal a bylaw;

NOW THEREFORE PURSUANT to the provision of the *Cities, Towns and Villages Act*, R.S.N.W.T., 1988, c-C.8 as amended by s.Nu.2003, the Council of the Municipality of Iqaluit, NU, in regular duly assembled, enacts as follows:

PURPOSE

The purpose of this Bylaw amendment is to establish new rates to the Business License Bylaw #624.
